

In 2009, Modest Needs' individual donors contributed \$1,360,245.00 to Modest Needs Foundation. During that same period, Modest Needs 'passed through' \$1,227,960.00 directly to persons who had applied for assistance from the organization, with the remainder of the funds contributed by individuals in 2009 being disbursed in January 2010. Modest Needs' remaining expenses, including salaries, were paid by grants made to the organization explicitly for this purpose.

In addition to acting as the CEO of the organization, to save money, and until such time as Modest Needs is in the financial position to afford the very substantial (\$350,000/year + ) fees that would be involved in hiring an outside firm to maintain a website and scope of that used by Modest Needs, at the request of Modest Needs' Board of Directors, the CEO works nights and weekends in tandem with Modest Needs' CTO to design, program, test and maintain the Modest Needs Foundation website. For this work, which constitutes a separate and distinct full time (40 hrs/wk) commitment to Modest Needs on the part of its CEO, the CEO of Modest Needs Foundation received \$73,505.00 in compensation from the organization - about one-fifth of the cost of hiring a development firm to maintain the website, and slightly less than one-half the cost of hiring an additional person to perform this work on a similar full-time basis. It is the intention both of the CEO and of Modest Needs' Board of Directors to transfer this additional work and associated compensation from the CEO to another individual/entity as soon as is practical for the organization. In the meantime, Modest Needs' Board of Directors thanks the CEO for his willingness to work approximately 80 hrs/wk performing these two separate but critical roles within the organization so that Modest Needs can appropriately maintain its most important asset - its website - while providing assistance to the maximum possible number of individuals and families who apply for Modest Needs' assistance each year.
